Established by JA London and District in 2001, the Alumni Award of Achievement has recognized the personal and professional achievements of former JA Company Program participants who exemplified the positive impact JA programs had on them. - The individual must have demonstrated a willingness to give back to their community through donations of time, money or other means; to any worthwhile cause or organization dedicated to community building
- Must be available to participate in-person at the award celebrations on October 23rd, 2025 (no posthumous nominations)
- Cannot have previously received the Alumni Award of Achievement through JA SWO
